

Changes in Policy & Legislation for supporting Family Caregivers

The United States has over 53 million adult family caregivers (AARP, 2020). As the population ages, the prevalence of people with chronic illness or disabilities who need some type of intermittent or long-term caregiving also increases. This presentation explores caregiving in the United States past, present and future. The impact of caregiving on families, communities, and organizations. It identifies gaps within the health care continuum and explains the current and new legislation which seeks to support and strengthen family caregivers through identification, engagement and education. We examine, through a case study one health system's use of community collaboration and organizational partnerships to create innovative supports to address the needs of family caregivers.

Most recently, has been supporting her advocacy for family caregivers through research examining identification and acceptance of the caregiver role.
